INSTRUCTIONS FOR ADDENDUM FOR USE IN FLORIDA

These instructions are to assist you in completing the Addendum for Use in Florida.

- 1. The Addendum for Use Nevada must be completed for all snorkeling, skin and/or scuba diving instruction, supervised activity or equipment rentals which take place within the State of Nevada.
- The Addendum for Use in Nevada must be completed with respect to all minor children who participate in snorkeling, skin and/or scuba diving instruction, supervised activities or equipment rental in the State of Nevada, regardless of whether the minor child and/or the natural guardian is a resident of or lives in the State of Nevada.
- 3. A minor child, as that term is used in the Addendum for Use in Nevada, means a person under 18 years of age at the time the Addendum for Use in Nevada is completed.
- 4. The Addendum for Use in Nevada is NOT a replacement for the release of liability, waiver of claims, express assumption of risk and indemnity agreement, but is to be completed in addition to that agreement when a minor child is the participant.
- 5. Please make sure that the Addendum for Use in Nevada is completed, signed, and dated before any participation by a minor child in any snorkeling, skin and/or scuba diving instruction and/or supervised activity and/or equipment rental takes place.
